According Mr. Emmanuel Ketaman Evortepe, the Executive President of the Foundation and the CEO of Fafaa 100.3 FM Dzodze, the concept was birthed nine years ago as a radio intervention program from the airwaves of Jubilee Radio 106.9 FM, Keta, and later moved to its present radio the Fafaa 100.3 FM six years ago.

The day of the grand finale also witnessed the official outdooring of the Duamenefa Foundation Ghana. Over 30,000 spectators made up of dignitaries from all walks of the divide were present to witness this great



## Intervention Yields Positive Results







During the arbitration to reverse the curse, interrogations are made with the alleged culprits all before a large crowd of onlookers The Duamenefa Foundation upon the receipt of the petition launched its independent investigations into the allegations and discovered that Mr. Afedovi Ahiable was indeed entangled in strange drunken escapades; hence the need for the Foundation to summon the relevant stakeholders, including the Ghana Police Force, the National Commission for Civic Education and the traditional authorities into the matter.

A mammoth crowd of over 3,000 people gathered at Glidzi to witness this arbitration. The procedures could not be completed so, the Foundation again collaborated with the traditional authorities to intervene through traditional arbitration and mediation.

The traditional authorities under the leadership of Togbi

Akpalu Agbali postponed the arbitrations to enable the families to resort to spiritual consultations according to their individual beliefs, hence prayers for interventions through the Lord and Savior Jesus Christ was employed to rescue Afedovi from his predicament.

When Mr. Ketaman on 14th August, 2019, called Mr. Ruben Ahiable, the victim's brother, during his Duamenefa programme to find out the condition of Afedovi Ahiable after the prayers. He informed Mr. Ketaman that Afedovi had completely recovered from his excessive consumption of alcohol.

When Mr. Ketaman asked if he could speak to Afedovi himself on phone, Ruben's answer was in the affirmative.
